A 23 year-old North Fond du Lac man is being held in the Fond du Lac County Jail and has been charged with five felony counts and one misdemeanor following allegations of sexual assault against a minor.

Jeremy J. Stoll of North Fond du Lac was arrested by North Fond du Lac and Fond du Lac police at Dillingers Tavern on Tuesday night. North Fond du Lac police received information that Stoll had sexually assaulted a 17 year old girl on several occasions dating back almost two years. According to the complaint, the girl met Stoll during 2003 when she was 15 years old. The victim told police that she and Stoll developed a boyfriend/girlfriend relationship, which she ended several weeks later. The girl reported that in December of 2003, she was invited to a party at Stoll's residence in North Fond du Lac. According to the girl, when she arrived at Stoll's residence, two of Stoll's friends left, leaving her and Stoll alone. The victim told police that she was eventually led to Stoll's bedroom and told to undress. When she refused, Stoll reportedly removed a knife from his pocket and held it to her throat saying that if she did not do as told, he would kill her. The girl told police that she then removed her jeans, shirt, and socks. Stoll reportedly pushed her down onto the bed and laid down on top of her. According to the girl, Stoll forcefully pushed her legs apart and had intercourse with her at that time. The victim told police that she yelled for Stoll to stop, but he again placed the knife to her throat and warned her that if she did not do as he told her, he would kill her. According to the victim, after the assault, Stoll told her that if she went to the police, he would kill her.

The victim also told police that she was approached by Stoll on the street in front of her residence approximately one week ago. The victim said that Stoll told her, "Come with me." When she refused, the victim said Stoll grabbed her by the hand and pulled her toward his car which was parked nearby. According to the victim, Stoll pushed her into the back seat and climbed in on top of her, closing the car door. The victim told police that Stoll then began rubbing her body through her clothing and fondling her breasts under her shirt. The victim said that she yelled for Stoll to stop and began struggling with him. After several minutes, she was able to get out of the car. She fled into her house and locked the doors.

Stoll made his initial appearance in court this morning. He was charged with one count of Sexual Assault of a Child Under 16 Years of Age, two counts of False Imprisonment, one count of Felony Intimidation of a Victim, and one count of Fourth Degree Sexual Assault. Based on Stoll's criminal record, a repeater enhancer was added to each count. Stoll is being held on a \$25,000 cash bond.
